MIN.1/4/2018-19 – Preliminaries

The Chairman welcomed the members to the third Board meeting and asked Mr. Kullow to open with a word of prayer.

MIN. 2/4/2018-19 – Confirmation of the previous minutes

The Chairman requested the Manager to take the members through the previous minutes. The minutes were read out aloud and it was proposed to be the true record of the last Board meeting by Mr. Abdi. He was seconded by Mrs. Famsahara.

MIN. 3/4/2018-19 - Matters arising

The members deliberated the effect of the SRC circular on the remuneration of members of the city/municipality boards and it was resolved that the latest circular SRC/TS/CG/3/61(38) dated 27th February 2019 takes effect.

MIN. 4/4/2018-19 – Review of the third quarter report

The Chairman read out the agenda and invited the Manager to take the members through the report.

The Manager took the members through the report and he briefed the members on the progress of the KUSP projects procurement process.

The Board directed the Manager to write letters to relevant Ministries to appoint competent project supervisors for the two KUSP projects so that value for money can be achieved.

MIN. 5/4/2018-19 – Municipality Budget 2019/2020

The Chairman introduced the agenda and asked the Manager to take the members through the item lines. The Manager informed the members that the County Treasury did not give any ceiling for the Municipality and the budget proposal before them is as per the functions cost. He also reminded them that the allocations can be more or less than what is captured depending on the County prioritization during the consolidation of the budget to be done by the County Executive Committee.

The members adopted the budget proposal of KES. 370,319,500/= and tasked the Chairman and the Manager to lobby with the County Executive Committee and the Assembly so that the budget is not slashed.

MIN. 6/4/2018-19 – KUSP Annual Plans and Budget 2019/2020

The Manager presented the UIG and UDG investment plans and budgets for the FY 2019/2020 for the Board adoption. The plans were scrutinized and unanimously adopted by the Board.
