MIN.1/3/2019-20 – Preliminaries

The Chair welcomed the members to the special Board meeting and asked Mr. Kulow to open with a word of prayer.

He briefed the members on the purpose of the meeting which is the preparedness for the Covid – 19 which is a global epidemic. He emphasized that the Municipality is very critical in putting up mitigation measures since we are bordering two Countries both of which have weak medical facilities.

MIN. 2/3/2019-20 – Manager's brief on Covid - 19

The Manager informed the members that H.E. the President of the Republic of Kenya has given a directive on the Covid – 19 and Mandera County has taken up measures spelt out in the

Executive Order. One of the directives is to form County Coordination Team which is Co-chaired by H.E. the Governor and the County Commissioner.

He informed the members that the team has been formed and has had three meetings so far. He also informed the members that H.E. the Governor of Mandera County has also given out a circular in preparation for the Covid – 19. In the circular, different entities were tasked to put in place mitigation measures. Mandera Municipality has been tasked with the enforcement of the orders on hygiene practices in the public areas by providing hand washing facilities and sensitization of the public through speaker –mounted vehicles.

He further informed the members that the public health officers attached to the Municipality are working hand in hand with their colleagues at the Ministry to screen all incoming passengers at the airstrip, crossing at the two international borders and the vehicles coming into Mandera from other towns within the County and Country.

MIN. 3/3/2019-20 – Discussion on Covid – 19 preparedness

The Chair introduced the agenda and asked the Manager to raised issues that requires deliberations and approval of the Board.

The Manager told the members that the sensitization has been started but he requires the approval of the Board for purchase of hand washing equipment for the public areas, hand sanitizers and protection gears for the sanitation workers since they are exposed due to the nature of their work.

The members deliberated on each of the issues at length and approved the incurring of the expenditure for the preparedness for the Covid – 19.

They also directed the Manager to do enough publicity on the preparedness and on the intervention being undertaken by the entity.


The Chair asked the members whether there is any other business. No other business were discussed.
