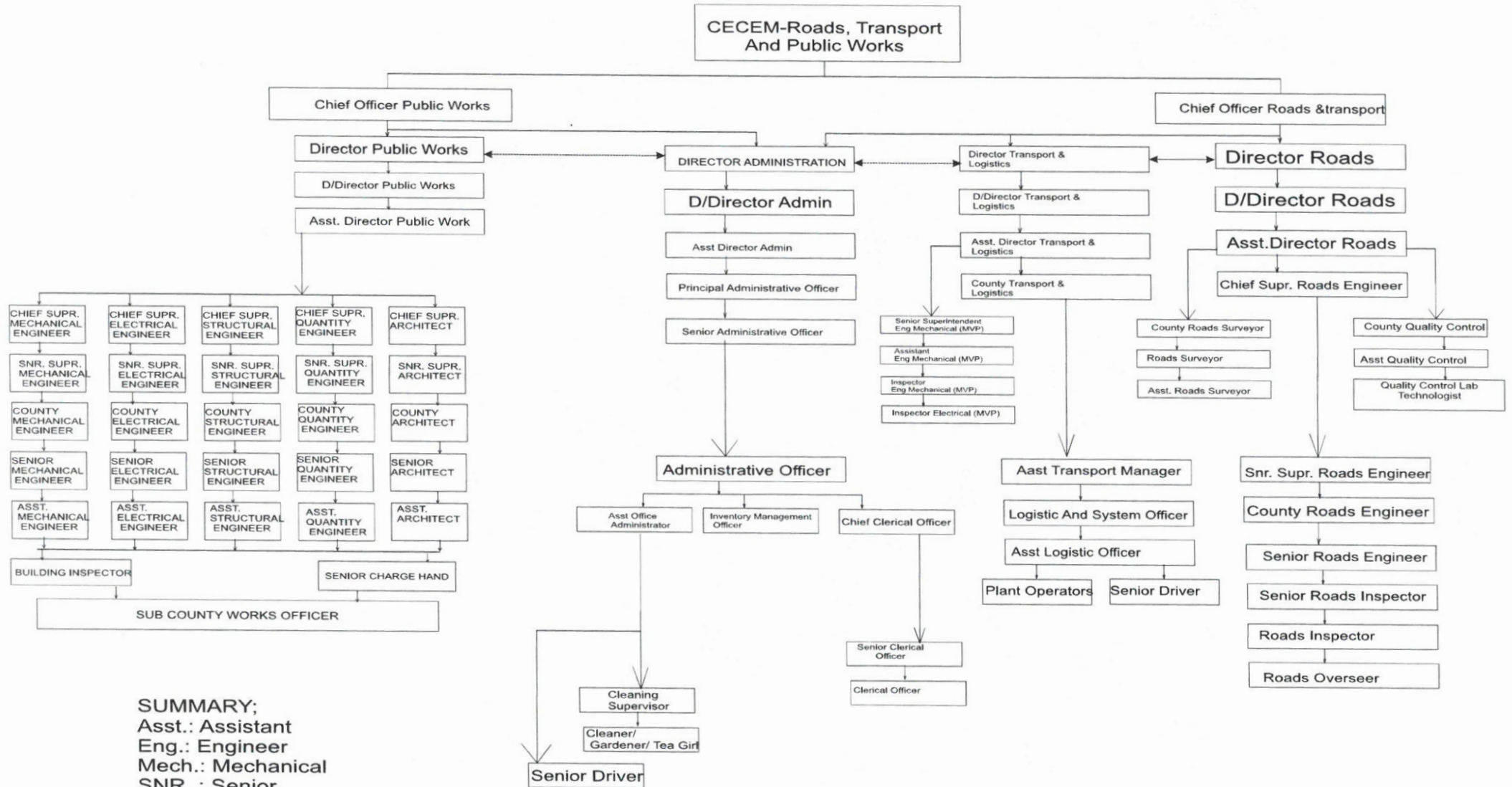
# Social Development Sectoral Chart (2025)
